2. I am aware that participating in the Events is an EXTREMELY HAZARDOUS ACTIVITY that can lead to severe personal injury, death or property damage. With full knowledge and appreciation of the many risks and dangers associated with participating in the Events, I acknowledge that I am voluntarily participating in the Events and that I VOLUNTARILY, KNOWINGLY AND FREELY ASSUME ALL RISKS ASSOCIATED WITH SUCH PARTICIPATION, known or unknown, anticipated or unanticipated, including the risk of negligence by persons or entities involved with the Events.
